Golf Outing Food and Beverage Arrangements

The sale and service of all alcoholic beverages is regulated by the New York State Division of Alcohol and Tobacco. The Vista at Van Patten Golf Club is responsible for the administration of those regulations. It is a policy; therefore, if any alcoholic beverages are donated, these items will be regulated and administered by Van Patten Golf Club staff. **There will be a \$500 administration fee for donated items.**

All donations must be dropped off to Van Patten Golf club **no later that one day prior of the event** for inspection and approval. An invoice including the amount of the donation and the name of the donator must be provided for our records.

Individual coolers on player's golf carts are prohibited and strictly enforced.

2025 OUTING AGREEMENT**

SHOTGUN STARTS

- Monday – Friday: 9:00 a.m. or earlier.
 - Saturday and Sunday after 1:00 p.m.
 - Full required players - 80 minimum.
 - Modified shotguns - 40-76 minimum.
 - 27 Hole Shotguns - 200 minimum.
- Special arrangements can be made if applicable.

ADDITIONAL CARTS

If it is necessary to order additional carts to accommodate your tournament a charge of \$85 per cart with a minimum of 7 carts will apply. If your event is canceled due to inclement weather, even if rescheduled, the charge of \$85 per cart will still apply for the canceled event.

ATTIRE

Proper golf attire. No tank tops, cut-offs, or short shorts. This applies to men and women.

COOLERS

We provide beverage carts daily.
NO OUTSIDE COOLERS OR ALCOHOL
WILL BE ALLOWED.

DATES HELD

Dates held without a deposit are at risk of being replaced. To reserve a 2025 date, please return your non-refundable deposit to secure your desired date.

WEATHER

Cancellation due to inclement weather or impending inclement weather will be at the sole discretion of Van Patten Golf Club.

FINAL GUEST COUNT

Final counts for all participants are due one (1) week prior to the event for both golf and food. This is the number you will be charged for, or the number in attendance, whichever is greater.

ROOM MINIMUM

Morning & Afternoon Minimum: \$2,000
After 5:00 PM Minimum: \$3,000

Events must meet the specified minimum spending requirement. If your event falls short, the room fee will be adjusted to meet the minimum.

ROOM RENTAL FEE

\$250.00 less than 50 guests.
\$375.00 50-100 guests.
\$500.00 over 100 guests.

**NY STATE SALES TAX
EXEMPTION**

New York State Sales Tax Exempt form (NY State Form ST-119.1) is due with your deposit. In order to take advantage of your exempt status, payment must be made with a check or credit card bearing the sales tax-exempt organizations name as it appears on your tax-exempt certificate (ST-119.1). Cash, Bank, & Cashier's checks cannot be accepted.

PAYMENT

Full Payment is required within 10 days of your outing.
